PURPOSE

This information document provides key information about the investment product, CFD on Cryptos. The information is required by law in order for you to understand the nature, risks, costs, potential profits and losses of this investment product and to help you to compare it with other investment products.

TRIVE Financial Services Malta Limited (hereinafter “**TRIVE MALTA**”) is registered in Malta with number C60473 and is authorised and regulated by the Malta Financial Services Authority (MFSA).

WARNING

You are about to purchase a product that is not simple and may be difficult to understand.

WHAT ARE CFDs?

Contracts For Differences (CFDs), are complex financial products in accordance with the applicable law. They are traded on ‘over-the-counter (‘OTC’) basis and not through a regulated market. CFDs, which are agreements to exchange the difference in value of a particular underlying instrument between the time at which the agreement is entered into and the time at which it is closed, allowing the investors to speculate on rising or falling prices of underlying instrument without requiring actual ownership.

An investor has the choice to buy (or go “long”) the CFD to benefit from the ‘base’ asset of a crypto pair rising in relation to the ‘variable’ or ‘quote’ asset; or to sell (or ‘short’) the CFD to benefit from the ‘base’ asset of a crypto pair falling in relation to the ‘variable’ or ‘quote’ asset.

The price of the CFD is derived from prices sourced by major liquidity providers to the OTC Crypto market. If an investor is long an ETH/USDT CFD and the price of the underlying crypto pair rises, the value of the CFD will increase - at the end of the contract TRIVE MALTA will pay the difference between the closing value of the contract and the opening value of the contract. Conversely, if an investor is long and the underlying crypto pair falls, the value of the CFD will decrease - at the end of the contract they will pay TRIVE MALTA the difference between the closing value of the contract and the opening value of the contract.

OBJECTIVES

The objective of the CFD is to allow an investor to gain leveraged exposure to the movement in the value of the underlying crypto pair without actually needing to buy or sell the underlying crypto pair. The exposure is leveraged since the CFD only requires a small proportion of the notional value of the contract to be put down upfront as initial margin and is one of the key features of trading CFDs. By way of example, if an investor buys 1 CFD with a contract size of 100 X-crypto, an initial margin amount of 25% and X-crypto/USDT is trading at 10.97 / 10.98, the initial investment will be \$274.5. ($10\% \times 100 \times 10.98$). The effect of leverage, in this case 4:1 (1 / 25%) has resulted in a notional value of the contract of \$1,098 (10.98×100). This means that for each 1 point change in the price of the underlying crypto pair, the value of the CFD changes by \$1. For instance, if the investor is long and the market increases in value, a \$1 profit will be made for every 1 point increase in that market.

However, if the market decreases in value, a \$1 loss will be incurred for each point the market decreases in value. Conversely, if an investor holds a short position, a profit is made in line with any decreases in that market, and a loss for any increases in the market.

The undated CFD does not have a pre-defined maturity date and is therefore open-ended. Undated contracts incur an overnight holding cost. There is no recommended holding period for either and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives.

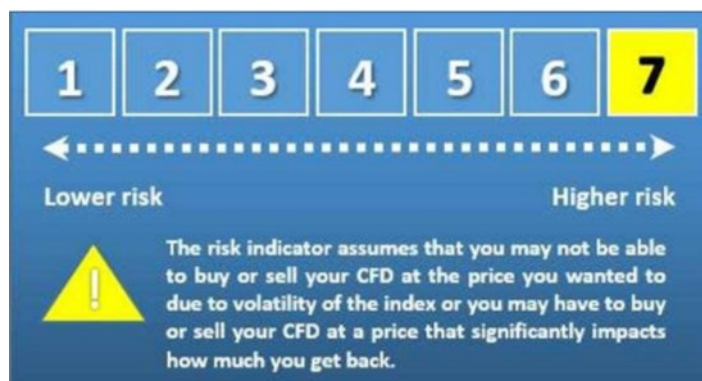
Failure to deposit additional funds in the case of negative price movement may result in the CFD being auto-closed. This will occur when there is not enough money of the account to cover the loss and the margin requirement. TRIVE MALTA also retains the ability to unilaterally terminate any CFD contract where it deems that the terms of the contract have been breached.

INTENDED RETAIL INVESTOR

CFDs are intended for investors who have knowledge of, or experience with, leveraged products. Likely investors will understand how the prices of CFDs are derived, the key concepts of margin and leverage, and that losses may exceed deposits. They will understand the risk/reward profile of the product compared to traditional share dealing, and desire short-term, high-risk exposure to an underlying asset. Investors will also have appropriate financial means, hold other investment types and have the ability to bear losses in excess of the initial amount invested.

RISK INVOLVED AND RETURNS

RISK INDICATORS



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level.

CFDs are leveraged products that, due to underlying market movement, can generate losses rapidly. Losses can exceed the amount invested and you may be required to deposit additional funds.

There is no capital protection against market risk, credit risk or liquidity risk.

Be aware of currency/crypto asset risk. It is possible to buy or sell CFDs in a currency/crypto pairs which is different to the base currency/crypto of your account. The final return you may get depends on the exchange rate between the two currencies/ cryptos. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make further payments to pay for losses. The total loss you may incur may significantly exceed the amount invested. Market conditions may mean that your CFD trade is closed at a less favourable price, which could significantly impact how much you get back. We may close your open CFD trade if you do not maintain the minimum margin that is required, if you are in debt to the company, or if you contravene market regulations. This process may be automated. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme section “what happens if we are unable to pay you”). The indicator shown above does not consider this protection.

PERFORMANCE SCENARIOS

The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. What you get will vary depending on how the market performs and how long you hold the CFD. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you. The following assumptions have been used to create the scenarios in Table 1:

COSTS

Trading a CFD on an underlying cryptos pair incurs the following costs:

This table shows the different types of cost categories and their meaning			
Undated	One-off entry and exit costs	Spread	The difference between the buy price and the sell price is called the spread. This cost is realised each time you open and close a trade.
		Currency Conversion	Any cash, realised profit and losses, adjustments, fees and charges that are denominated in a currency other than the base currency of your account, will be converted to the base currency of your account and a currency conversion fee will be charged to your account.
	Ongoing costs	Daily holding cost	A fee charged to your account for every night that your position is held. This means the longer you hold a position, the more it costs.

TRADING STRATEGY

CFDs are intended for short term trading, in some cases intraday and are generally not suitable for long term investments. There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a CFD on a cryptocurrency pair at any time during market hours.
