WHAT ARE COOKIES?

Our Site uses a technology called "cookies". A cookie is an element of data (usually a very small file) that a website can send to Your browser, which may then store it on Your computer or mobile device. These cookies allow Us to correctly operate the Site and/or to provide You with web pages or content that are tailored to You. For example, some cookies remember Your custom preferences. This information can, in some cases, be carried from one visit of Our Site (or related site) to the next (for example, to help You avoid having to re-enter certain information when You visit the same page later). Some of these cookies require Your consent (as explained below).

Some cookies are created for each session when You visit Our Site, while others are persistent and may remain for a number of months or years to facilitate Your access to Our Site.

WHY WE USE COOKIES

We absolutely respect Your right to privacy. We use cookies to ensure the functionality of Our Site and to make Your website experience better. TYPES OF COOKIES

Classification of cookies:

DURATION

- Session Cookies: These are temporary cookies. Once You close Your browser, it expires.
- Persistent cookies: These cookies remain on Your hard drive until You erase or cookie expiration date.

PROVENANCE

- First- party cookies: These cookies are put on Your device directly by this visiting web site.
- Third -party cookies: These cookies are put on Your device, not by this website, but a third-party like analytics

PURPOSE

- Strictly necessary cookies: These are essential cookies for You to browse the website and use its features.
- Marketing Cookies: These cookies track Your online activity to help advertisers deliver more relevant advertising. These cookies scan share that information with other organisations or advertisers.
- Statistics cookies: These cookies collect information about how You use the website. None of this information can be used to identify You.
- Preferences cookies: These cookies allow this website to remember choices You have made in the past.
