### **PARTICIPANTS**

## **RESTRICTION**

### **MECHANISM OF THE PROMOTION**

  trading volume and the net deposit refer to the trading volume and the net deposit of the

- Illegal trading positions will not be taken into consideration while calculating profit rate and required minimum trading volume.
- Open trade will not be included in the calculation of profit rate and required minimum trading volume.
- Internal transfer will not be taken into consideration while calculating net deposit and trading volume.


